## AMENDMENT NO. 2 AGREEMENT FOR ANIMAL SHELTER SERVICES BETWEEN CITY OF RAPID CITY AND THE HUMANE SOCIETY OF THE BLACK HILLS

WHEREAS, the City of Rapid City and the Humane Society of the Black Hills previously engaged in negotiations and those negotiations at one point included Pennington County; and

WHEREAS, the payment from the City of Rapid City to the Humane Society of the Black Hills that was included in the original agreement was incorrect in that it included Pennington County's portion of payment;

NOW, THEREFORE, be it agreed as follows:

This Amendment No. 2 to Agreement for Animal Shelter Services between City of Rapid City and the Humane Society of the Black Hills dated December 1, 2003, is made and entered into this <u>if</u> day of <u>Time</u>, 2004. All terms and conditions of the Agreement for Animal Shelter Services between City of Rapid City and the Humane Society of the Black Hills shall remain in full force and effect except as specifically modified herein and except as specifically modified by Amendment No. 1 to the Agreement for Animal Shelter Services between City of Rapid City and the Humane Society of the Black Hills dated March 2, 2004.

Paragraph 4 of the Agreement for Animal Shelter Services between City of Rapid City and the Humane Society of the Black Hills dated December 1, 2003, is hereby amended to read-as follows:

4. CITY shall pay SOCIETY Eleven Thousand One Hundred Eleven Dollars and Eleven Cents (\$11,111.11) on or before the first day of each month for the period from April 1, 2004 through December 31, 2005. Beginning January 1, 2006 the monthly payment to the SOCIETY shall be increased by the lesser of 3% or a percentage equal to the annual increase of the Consumer Price Index as designated for all urban customers for the most recent year ending December 31.

In the event the Society receives such notice from Pennington County terminating its animal shelter agreement, the Humane Society shall immediately notify the City.
