

**ADDENDUM TO THE MEMORANDUM OF AGREEMENT DATED  
FEBRUARY 3, 2009 BETWEEN THE CITY OF RAPID CITY AND  
DESTINATION RAPID CITY**

WHEREAS, the City of Rapid City (“City”) and Destination Rapid City entered into a Memorandum of Agreement on February 3, 2009 whereby Destination Rapid City was allowed to place information kiosks in the public right-of-way in the downtown area and on public property at the Rushmore Plaza Civic Center; and

WHEREAS, the original Memorandum of Agreement contemplated seven kiosks, identified as Exhibits “A” through “G” attached to the original Memorandum of Agreement; and

WHEREAS, Destination Rapid City desires to place two more information kiosks in the downtown area, as identified on the attached Exhibits “H” and “I”; and

WHEREAS, the parties desire to amend the agreement to include the two new kiosks.

NOW THEREFORE, it is agreed as follows:

1. Destination Rapid City may place two additional information kiosks in the downtown area as identified on the attached Exhibits “H” and “I”.
2. The provisions of the February 3, 2009 Memorandum of Agreement shall remain in full force and effect.
