Finance Officer Pauline Sumption called the meeting to order at 3:00 P.M. with the following Committee members present: Mayor Sam Kooiker, Council President Dave Davis, Council Vice President Bonny Petersen, United Way Executive Director Renee Parker, Assistant Finance Officer Mary Floto, Accounting & Grants Manager Connie Ewing, Community Development Director Barb Garcia and Administrative Coordinator Sharlene Mitchell.

Sumption reviewed the Big Brothers/Big Sisters reserve requirements. Discussion followed regarding the funding provided to the Canyon Lake and Minneluzahan Senior Centers and the proposal to reduce the subsidy allocations by 5%. Parker addressed the impact of the current economic climate on budgets, grants and donations. Parker supported the proposal noting that implementing the reductions in small annual increments will not cripple the receiving organizations but will put them on notice that they must find alternative funding sources.

Motion was made by Parker, second by Davis and carried to recommend funding of the following subsidy requests as amended and to require that all subsidy recipients continue to provide the mid-year reports:
