

RESOLUTION 2014-003  
ESTABLISHING AND RE-ESTABLISHING PETTY CASH FUNDS, CHANGE  
FUNDS AND TRAVEL FUNDS

WHEREAS, it has been determined that various departments throughout the City of Rapid City require Petty Cash Funds, Change Funds and Travel Funds to operate the departments more efficiently; and

WHEREAS, the Cash Handling Audits I and II prepared by Compass have made the recommendation that the Finance Office create and maintain a complete and accurate list of all petty cash and change funds; and

WHEREAS, such list should properly be supported by City Council resolutions; and

WHEREAS, Public Works has requested an additional \$100 petty cash fund for the Traffic Engineering Division to operate the division more efficiently.

NOW, THEREFORE, BE IT RESOLVED, that the following petty cash funds, change funds (CF) and travel funds be hereby established(\*) and re-established as follows:


