Last week I was riding my mountain bike down the bike path and had a real scare.

I ride pretty hard and try to get a good workout, so I was probably going 20 mph (eastbound) as I entered the bridge across from the swim center on Omaha St.

I ride from well past the fish hatchery all the way to Taco John's on Campbell St., and it's, by far, the darkest area (even in broad daylight) on the path.

All you can see is the "light at the end of the tunnel" as they say.

Well, some wonderful citizen broke a liquor or beer bottle and left it there. I completely ruined both tires, tubes, and almost myself, with a catastrophic pair of nearly simultaneous blowouts at that speed.

My concern is with cyclists like me, yes, but also with the small children known to frequent that particular area due to its proximity to Rapid Creek.

I've personally seen them in bare feet more times than I could count.

Please advise as to your thoughts on lighting the area under that bridge so all citizens can feel safer. Additionally, I'm not completely sure that general safety is very good at this point, either, having seen groups of inebriated folks hanging around in the darkness.
