RESOLUTION OF SUPPORT FOR THE ESTABLISHMENT OF THE RUSHMORE PLAZA CIVIC CENTER EXECUTIVE TASK FORCE

WHEREAS, the Rushmore Plaza Civic Center Board of Directors has been working diligently since December of 2011 to address the aging and deficient 37 year old Don Barnett Arena; and

WHEREAS, the Rushmore Plaza Civic Center Board of Directors has commissioned several studies to date including: ADA and Life Safety Assessment Study, Building Code Compliance Study, as well as, a Feasibility and Market Analysis Study, expending over \$200,000 in RPCC generated revenues for these studies; and

WHEREAS, the Rushmore Plaza Civic Center Board of Directors established the Civic Center Futures Committee comprised of 18 local business owners, youth, former mayor and city councilmen, tourism, economic development, and political leaders. For nine months, the CCFC met biweekly and studied all aspects of the aging facility to determine the appropriate course of action for the future of the facility. Ultimately, the RPCC Board accepted the recommendations of the Civic Center Futures Committee which was to "undertake a comprehensive feasibility study for the construction of a new arena;" and

WHEREAS, the Rapid City Common Council voted to hire consultants to determine an initial design and cost estimate based on the recommendation brought forward by the CCFC to the RPCC Board; and

WHEREAS, the Rushmore Plaza Civic Center Board of Directors unanimously supports the BLUE CONCEPT, as proposed by the consultants for expansion of the Rushmore Plaza Civic Center and repurposing of the Don Barnett Arena; and

NOW, THEREFORE, BE IT RESOLVED, the Board of Directors of the Rushmore Plaza Civic Center, fully supports the establishment of the RUSHMORE PLAZA CIVIC CENTER EXECUTIVE TASK FORCE comprised of the following entities for the purpose of moving the expansion of the Rushmore Plaza Civic Center to ground breaking.
