Resolution No. 2014-117

A Resolution to Set the Amount of Penalties and Late Fees for Parking Violations

WHEREAS, the City of Rapid City has enacted ordinances to govern the parking of vehicles within the city; and

WHEREAS, violations of the various parking regulations subject the violator to a penalty; and

WHEREAS, the ordinances provide that the amount of the penalty and late fee are to be set by resolution of the Common Council; and

WHEREAS, the Common Council finds that the penalties and fees contained herein are fair, reasonable, necessary and proper for the associated violations of parking regulations.

NOW THEREFORE, BE IT RESOLVED by the Common Council of the City of Rapid City that the following penalties and late fees are established immediately upon the effective date of this Resolution:

BE IT FURTHER RESOLVED by the Common Council of the City of Rapid City that the following penalties and late fees for over-time parking violations are established effective February 1, 2015:

No penalty shall be assessed if the vehicle has had no previous violations of any parking regulations in the ninety days preceding the present violation. A courtesy notice shall be issued informing the owner or operator of the violation and the fact that subsequent violations will be assessed a penalty. If the vehicle has had one or more parking violations in the ninety-day period preceding the present violation, the owner or operator shall, within 72 hours from the time when the notice of violation was attached to the vehicle, pay to the city's Finance Office as a penalty for and in full satisfaction of the violation, the amount shown below. If the person fails to pay the penalty within 72 hours, he or she shall pay to the Finance Office as a penalty for and in full satisfaction of the violation, the sum total of the penalty and late fee shown below.

In the event of a computer hardware or software malfunction, or other failure that prevents the police department from accessing the records of parking violations, all penalties for violations of the above listed code sections shall be \$10, with a \$5 late fee, without regard to the number of previous violations.
