11. Other /Comments; In the switch to the new tax software, several properties that met all criteria for an owner occupied classification had that classification dropped. When the problem was discovered, all properties in this situation were reviewed and the errors discovered.

(No tax may be abated on any real property which has been sold for taxes, while a tax certificate is outstanding. Any abatement on property within corporate limits of a municipality must be first approved by the governing body of the municipality.)
