**Project Products:** The Commission proposes to use 2015-16 Federal Grant funds for three Project Products. The highest priority is placed on the continuation of the West Boulevard Historic District Resurvey. Second, the Commission will promote and conduct an educational program by hosting a 3 day preservation workshop and coordinating Preservation Month activities. Third, Historic Preservation Commission members and city staff will participate in training which continues their own knowledge in historic preservation topics.

#### PROJECT SUMMARY:

#### West Boulevard Historic District Resurvey

The West Boulevard Historic District in Rapid City was added to the National Register in 1974 and received a boundary increase in 1995. It has been over twenty years since this area was last surveyed. As such, this project has high priority in this grant proposal. Phase 1, 2, and 3 of the project were accomplished using grant funding in in 2014 and 2015. The remaining Phase 4 of the Project is proposed to be completed using funding in 2016.

#### **Educational Program**

The Commission proposes to coordinate a 3 day seminar/workshop program featuring Historic Preservation Consultant, Bob Yapp. The Historic Preservation Commission has contacted Bob Yapp, received pricing estimates for services, and discussed the potential to tentatively hold the seminar in fall of 2015 or spring of 2016. In addition to a Bob Yapp seminar, the Commission will use grant funding to host a booth at the Black Hills Home Builders Association Home Show and engage in other outreach/education activities during Historic Preservation Month.

#### **Personnel Training**

In order to stay current on historic preservation methodologies, train new Commission members, and comply with the requirements of the Certified Local Governments Agreement, the Commission members shall participate in training sessions offered at the local, regional, State and National (if applicable) level. Opportunities for personnel training include:

- State History Conference
- Bob Yapp workshops

The Black Hills Home Builders Association Home Show will take place in late March 2016. Preservation month activities will take place in May.

**Personnel Training**: Training events for personnel will be completed as they come available, prior to the end date of the grant.
