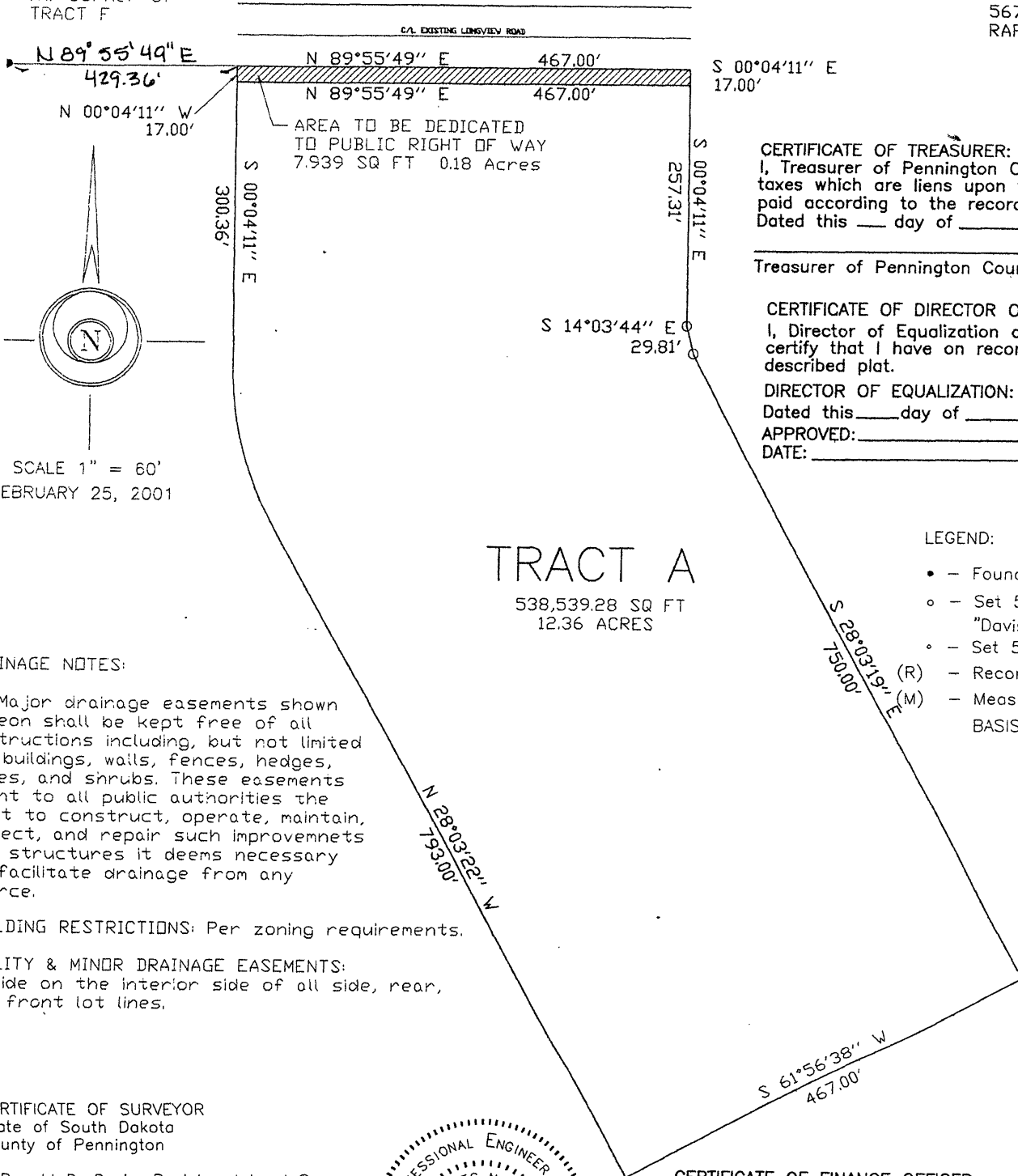

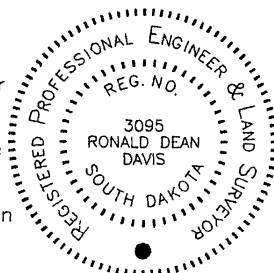
LOADING RESTRICTIONS: Per zoning requirements.
