July 6, 2004

Pursuant to due call and notice thereof, a regular meeting of the City Council of the City of Rapid City was held at the City/School Administration Center in Rapid City, South Dakota on Tuesday, July 6, 2004 at 7:00 P.M.

The following members were present: Mayor Jim Shaw and the following Alderpersons: Jean French, Tom Murphy, Ron Kroeger, Bill Waugh, Ray Hadley, Jeff Partridge and Sam Kooiker. The following Alderpersons arrived during the course of the meeting: None; and the following were absent: Alan Hanks, Rick Kriebel, and Martha Rodriguez.

Staff members present included City Finance Officer Jim Preston, Acting Public Works Director Ted Vore, Growth Management Director Marcia Elkins, City Attorney Jason Green, Parks and Recreation Director Jerry Cole and Administrative Assistant Jackie Gerry.

Approval of Minutes

General Public Comment

Mayor Shaw recognized Lisa Sissenstein who provided a copy of a letter addressed to the Pennington County States Attorney's office outlining a complaint regarding action taken by the Mayor, Council and City Attorney's Office on the matter of calling a Special Council meeting to consider a malt beverage license.

Bid Openings

The following companies submitted bids for No. CC070604-01 Card Key Security System for the Water Treatment Plant: 1) Dakota Security Systems, Inc.; 2) Gold West Technologies, Inc.; and 3) door Security Products, Inc. Staff has reviewed the bids and recommends award to Dakota Security Systems, Inc. Motion was made by Partridge, seconded by Waugh and carried to award the Card Key Security System Project No. WRP04-1384 to the lowest responsible bidder meeting specifications, Dakota Securities, Inc., based on their low unit prices bid for a total contract amount of \$48,250.42.

The following companies submitted bids for a 72" Out Front Mower for the Parks Department: 1) Midwest Turf; 2) Sun Turf; 3) Jenner Equipment; 4) Jenner Equipment; and 5) Rapid Valley Equipment. Staff has reviewed the bids and recommends award to Jenner Equipment. Motion was made by Partridge, seconded by Waugh and carried to award the 72" Out Front Mower for the Parks Department to the lowest responsible bidder meeting specifications, Jenner Equipment Company, based on their low unit prices bid for a total contract amount of \$15,620.00.

Items from the Mayor

Motion was made by Waugh, seconded by Kroeger and carried to approve the following appointments to the Planning Commission: Debra Hadcock, Ward 2; Martha Rodriguez, Ward 3; and Pete Anderson, Ward 5.

Mayor Shaw recognized Fire Chief, Gary Shepherd who reported his department had been approached by the Pennington County Commission with an inquiry of interest in demolishing three vacated houses for training purposes. Shepherd pointed out that these homes were located on Kansas City Street east of the courthouse. His interest is using these vacated homes were for search and rescue drills. For the privilege of using these structures, the County requested they be allowed to dispose of the debris at the Rapid City Landfill free of charge. Motion was made by French, second by Johnson to waive the Rapid City Landfill disposal fee for Pennington County for demolition debris from the building structures. Alderman Partridge offered a friendly amendment to charge the minimum fee of \$10.00 per ton for disposal of demolition debris. Alderman Kooiker offered a second friendly amendment that debris not normally accepted at the Rapid City Landfill, not be taken to the landfill for disposal. The motion maker accepted the friendly amendments. Upon a vote being taken, the motion as amended carried.

Items from Council Members/Liaison Reports

Motion was made Kooiker, seconded by French to set a Special Council meeting or special Information meeting during evening hours within the next several weeks to discuss the City Council Policies & Procedures. Substitute motion was made by Johnson, seconded by Waugh to refer this issue to the Legal & Finance Committee meeting. Kooiker addressed the structuring of the committees and having only five members comprise each of those committees. Upon a roll call vote being taken, the following voted AYE: Murphy, Johnson, Chapman, Kroeger, Waugh, Olson, and Partridge; NO: French, Hadley, and Kooiker. Motion carried 7 to 3.

Alderman French pointed out a Smoking Ordinance adopted by the City of Sioux Falls; and moved to Request the City Attorney's Office to prepare a similar smoking ordinance. The Chair declared the motion died for lack of a second. Motion was made by Kooiker, second by French to request the City Attorney's Office to prepare a Resolution asking the State legislature to clarify their position on smoking in public places; and bring the Resolution to the Legal & Finance Committee meeting for consideration. Motion carried.

Alderman Kooiker reported on the deteriorating condition of Signal Drive and moved to request the Public Works Department staff to assess the condition of Signal Drive and bring a recommendation to the Public Works Committee meeting. Second by Hadley. Motion carried.

Alderman French addressed the issue of voting by telephone by Council members. Motion was made by French, seconded by Kooiker to place a moratorium on further activity of voting by telephone, by Council members, until the full Council has had an opportunity to discuss this practice. Upon a roll call vote being taken on the motion, the following voted AYE: French, Johnson, Waugh, Hadley, Olson, Partridge, and Kooiker; NO: Murphy, Chapman and Kroeger. Motion carried 7 to 3.

Alderman Murphy commented he would not support an audit of the Professional Service Agreement for the Stoney Creek Booster Station. City Finance Officer Preston explained a typical audit includes a review the Council minutes to see that Council approved the agreement; payments were made in accordance with the agreement; ascertain that federal/state requirements were followed; review payments and cancelled checks. Estimated cost for a typical audit would be approximately \$500. Ordinance No. 4072, Repealing Chapter 15.12 of the Rapid City Municipal Code in its Entirety and Adopting a New Chapter 15.12 of the Rapid City Municipal Code Entitled Building Codes Adopted (No. LF061604-08), having passed the first reading on June 21, 2004, it was moved by Partridge, seconded by Kroeger that the title be read the second time. City Attorney Green asked for consideration of the following amendment to the ordinance: Be It Further Ordained by the City of Rapid City that Tables 100-D and 100-E are amended by adding the following language: For excavation and fill on the same site, the fee shall be based on the volume of excavation or fill, whichever is greater.
