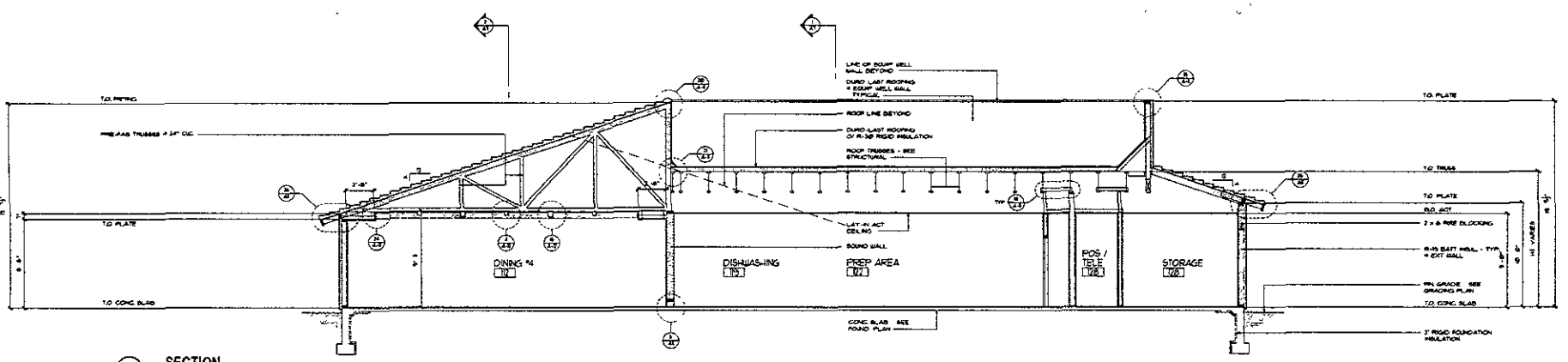
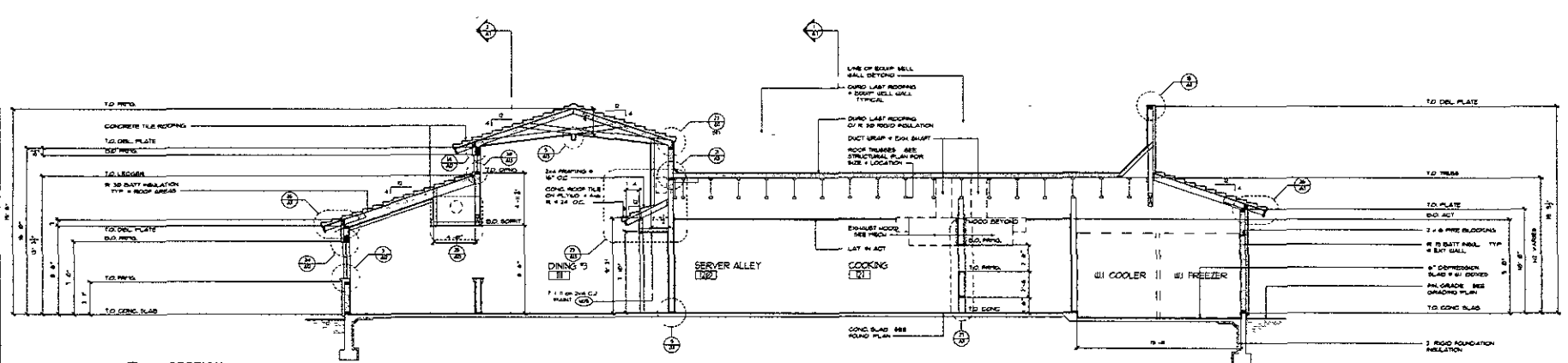


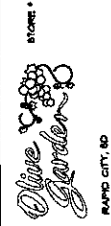
1 RIGHT ELEVATION

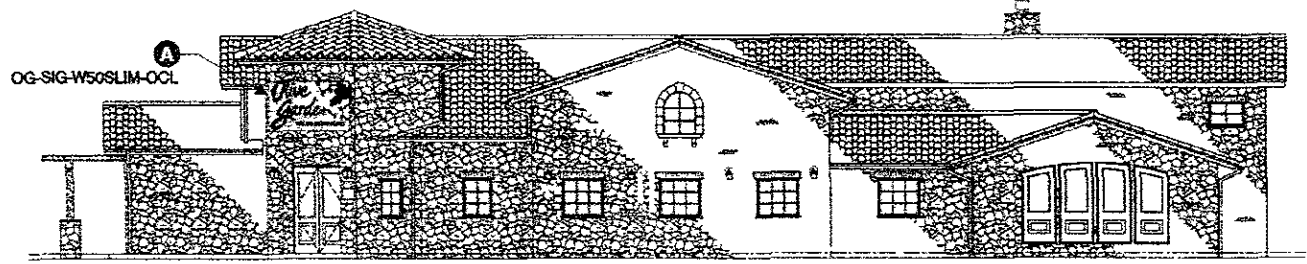

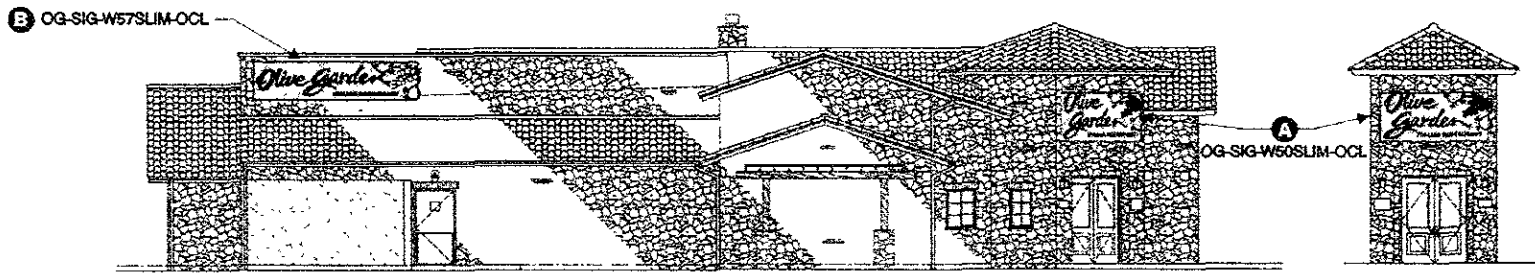

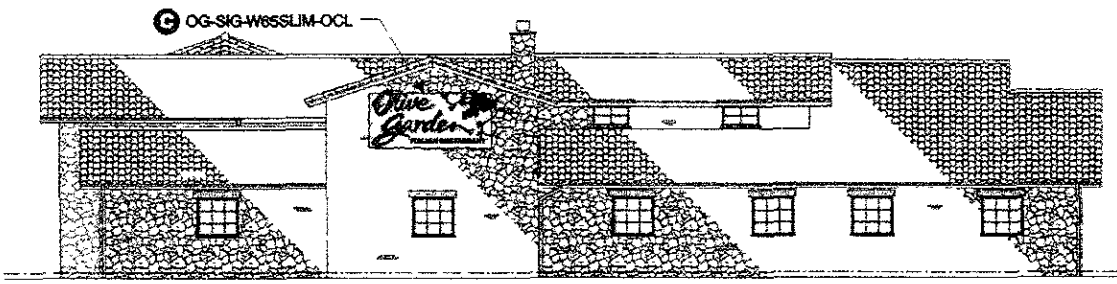


A FRONT ELEVATION "OG-SIG-W50SLIM-OCL" (1) REQUIRED AT ENTRY

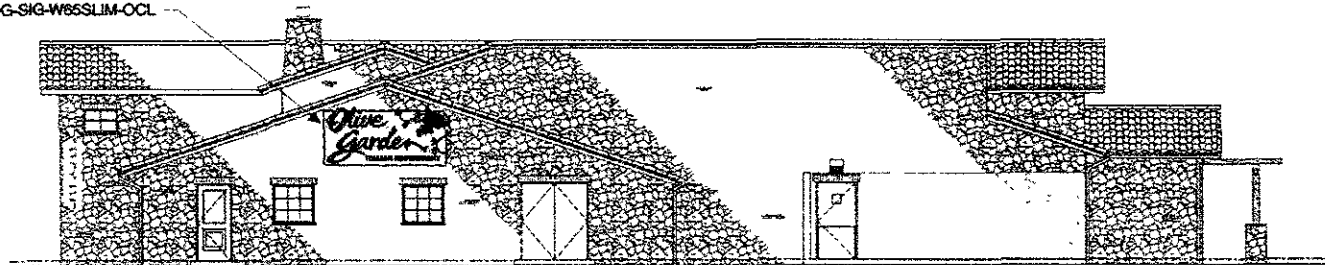

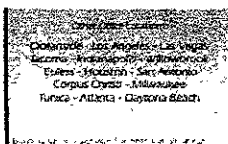
