RECOMMENDATION:

Staff recommends that the Variance to the Subdivision Regulations to waive the requirement to install curb, gutter, sidewalk, street light conduit, water, sewer, and pavement along the section line and access easement, and to waive requirements to install street light conduit and sidewalks along West Chicago Street as per Chapter 16.16 of the Rapid City Municipal Code be approved with the following stipulation:

1. Prior to City Council approval, the applicant shall sign a waiver of right to protest any future assessments for the improvements along West Chicago Street and the Section Line Highway as they abut the subject property.

GENERAL COMMENTS:

The applicant has submitted a Variance to the Subdivision Regulations to waive the requirement to install curb, gutter, sidewalk, street light conduit, water, sewer and pavement along a section line highway and an access easement and to waive the requirement to install street light conduit and sidewalk along West Chicago Street as they abut the subject property. In addition, the applicant has submitted a Preliminary Plat to subdivide the subject property into two lots. (See companion item #05PL112)

On June 6, 2005, the City Council denied without prejudice at the applicant's request a Preliminary Plat to replat three lots into two lots, which included the subject property. In addition, the City Council denied without prejudice at the applicant's request a Variance to the Subdivision Regulations to waive the requirement to install curb, gutter, sidewalk, street light conduit, water, sewer and pavement along the section line highway and the access easement and to waive the requirement to install street light conduit and sidewalk along East Chicago Street as they abut the subject property.

On December 6, 2004, the City Council approved a Layout Plat to subdivide three parcels into two lots, which included the subect property.

The subject property is located along West Chicago Street near the Sturgis Road intersection. Currently, a car sales lot is located on proposed Lot BR. The balance of the site is void of any structural development.

STAFF REVIEW:

Staff has reviewed the Variance to the Subdivision Regulations and has noted the following considerations:

West Chicago Street: West Chicago Street is located along the south lot line of the subject property. Currently, a sidewalk has not been constructed along this section of West

Chicago Street. Requiring the construction of a sidewalk along West Chicago Street as it abuts the subject property will result in a discontinuous street section. As such, staff is recommending that the Variance to the Subdivision Regulations to waive the construction of a sidewalk along West Chicago Street be approved with the stipulation that the applicant sign a waiver of right to protest any future assessment for the improvement.

Private Access Easement: The Preliminary Plat identifies a 40 foot wide private access easement located across proposed Lot BR to an existing lot located directly west of the subject property. The access easement is classified as an industrial street requiring that it be located in a minimum 59 foot wide easement and constructed with a minimum 26 foot wide paved surface, curb, gutter, sidewalk, street light conduit, water and sewer. The access easement is currently paved as a part of the adjacent parking lot. The proposed associated Preliminary Plat to reconfigure two lots does not result in an increase in the existing density. In the past, the Planning Commission and the City Council have granted similar Variance requests when the associated platting did not result in an increase in density. As such, staff is recommending that the Variance to the Subdivision Regulations to waive the improvements along the private access easement be approved.

Section Line Highway: A section line highway is located along the east lot line of the subject property. The east half of the section line highway is located on an adjacent property under different ownership from the subject property. In the past, the City Council has indicated that a section line highway should be vacated if a street is not to be constructed within the highway. The applicant has submitted a letter from the adjacent property owner indicating that they oppose vacating the section line highway, and, subsequently, will not sign the Vacation of Section Line Highway Petition. As such, staff is recommending that the Variance to the Subdivision Regulations to waive the requirement to install curb, gutter, sidewalk, street light conduit, water, sewer and pavement along the section line highway be approved with the stipulation that the applicant sign a waiver of right to protest any future assessment for the improvement.

<u>Legal Notification Requirement</u>: The receipts from the certified mailings have not been returned. Staff will notify the Planning Commission at the July 7, 2005 Planning Commission meeting if this requirement is not met. Staff has not received any calls or inquires regarding this proposal.
