<u>RECOMMENDATION</u>: If the Planning Commission believes reallocating costs between previously approved project costs for Revised Tax Increment District #39 is appropriate, the Planning Commission shall recommend approval of the reallocation of costs as outlined in the Revised Project Plan and the attached resolution.

GENERAL COMMENTS: This staff report has been revised as of July 12, 2006. All revised and/or added text is shown in bold print. This item was continued at the July 6, 2006 Planning Commission meeting. No other portion of this staff report has been revised.

Tax Increment District #39 was created April 21, 2003 to assist in the development of East Rapid Plaza located east of Century Road, north and west of East North Street and generally south of the railroad right-of-way and I-90 Exit 60. The funds were to relocate Western Area Power Administration power lines that cross the site, extend existing water and sewer to the site, construct traffic signals and turn lanes on East North Street and oversizing costs for Anamosa Street including acquiring right-of-way.

STAFF REVIEW: The developer is now requesting a reallocation of the costs of the previously approved Revised Project Plan costs. The applicant is proposing to increase the project costs of extending the existing water and sewer to the site. The applicant is requesting that the \$200,000 of contingency costs under the Other Necessary and Convenient Costs line item be reallocated to the extension of water and sewer line item. The contingency line item would be zero and the line item to extend existing water and sewer to the site would be \$250,000. All other costs remain the same and the tax increment base will not be reestablished.

If the Planning Commission believes reallocating costs between previously approved project costs for Revised Tax Increment District #39 is appropriate, the Planning Commission shall make the recommendation to approve the Revised Project Plan and the attached resolution approving a reallocation of project costs for the revised Tax Increment District #39.
