Park Shelter Information

Rapid City Growth at the Rapid City of those of you who have secured one of our two park shelters that are available for reservation, known as Canyon Lake #1, and Old Storybook Island, WE WELCOME YOU!

The City of Rapid City park system is well marked with regulations at the Canyon Lake Park entrance as well as in prominent locations along the bike path. The four major restrictions are:

- 1. NO ALCOHOL BEVERAGES
- 2. PARK CLOSING IS AT 10PM
- 3. ANIMALS ARE TO BE LEASHED
- 4. ELECTRIC OUTLETS ARE FOR FOOD PREPARATION ONLY

Payment must be made at the time of reservations. Your paid reservation guarantees that the park shelter is available to you and your party. A schedule of the use of the shelter is posted on the bulletin board. Please bring a copy of your receipt as proof of reservation. The shelter may be reserved throughout the day by different parties. Please respect the next reserved time slot and clean up behind yourself. The group that uses the shelter after you will appreciate the use of a clean park shelter.

In case of a cancellation, the shelter fee shall be refundable only if we receive six days notice prior to the reservation.

Each shelter has electrical outlets (15 amps), attached bathrooms and lights which come on at 6 PM. There are tables inside the shelter to accommodate 36 people. Additional tables are normally located near by. If you anticipate a large group you may want to bring some of your own trash bags. Trash should be placed in the nearby dumpster.

You may decorate the shelter and various entrance or parkway drives for purposes of offering directions to your event, but PLEASE DO NOT POUND NAILS INTO ANY TREES. Use tape or ribbons, etc. You may rent from private sources tents or other props to be placed at your park shelter with permission from the Parks Superintendent.

We strive to keep the shelters reasonably clean and the facilities working properly but occasionally problems occur that are beyond our control. Please let us know of any problems so that they can be corrected. Damages to the property caused by mis-use will be billed to the user on record.

We are proud of our park system and want you to truly enjoy yourselves. We look forward to your visits. Have a wonderful time.
