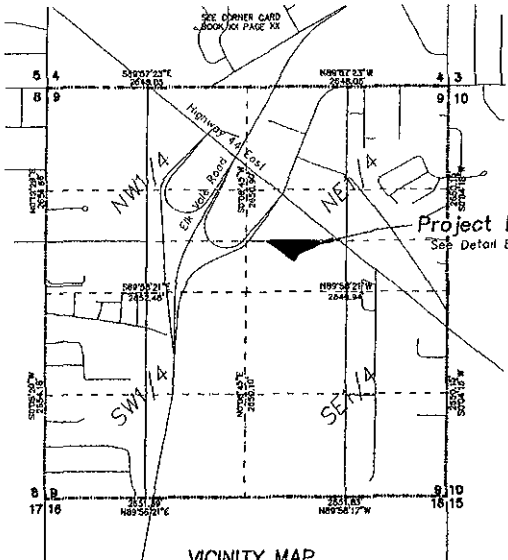

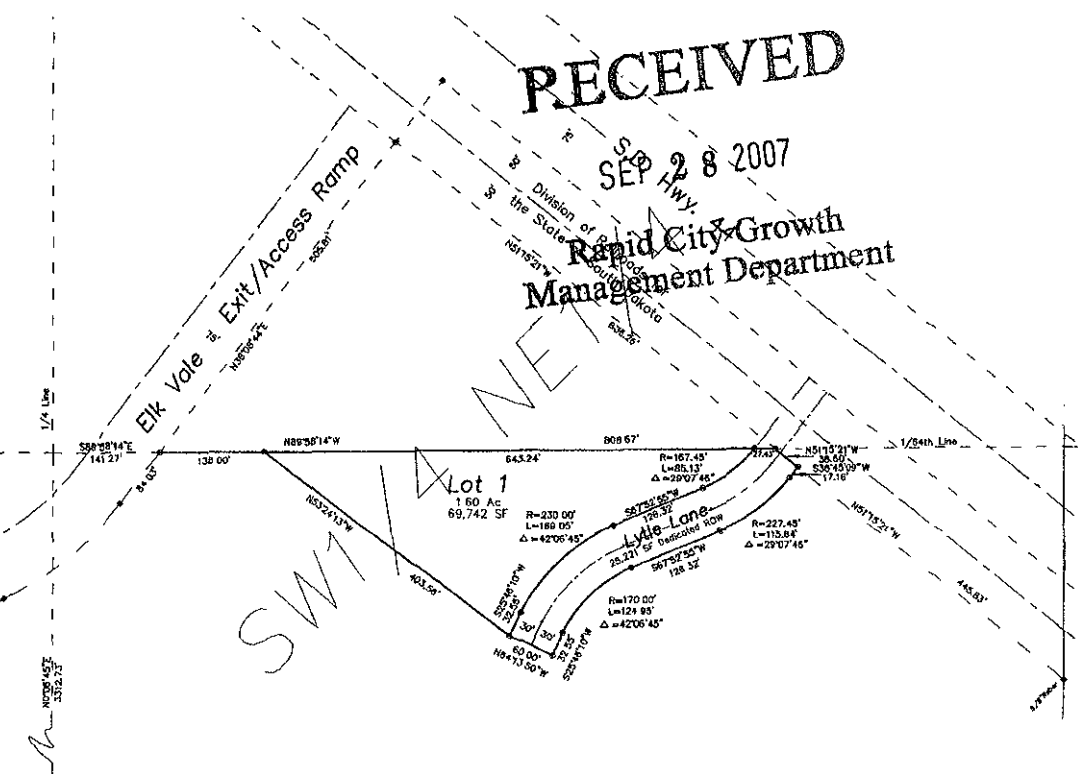
Utility and Minor Drainage Easements 8' on the interior side of all lot lines

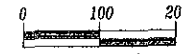
Project Location
