Letter of Intent for Final Planned Commercial Development Soft Power Parking Phase III

Development Summary

PCD Area: 633,214 sq.ft. or 6.337 acres

The Soft Power Parking Area is the large parking complex located on the eastern side of Rushmore Crossing. It is designed to handle the parking (shared) for all retail on Rushmore Crossings eastern side (excluding the Target Site - Phase I). It has been laid out at 2.5 stalls / 1000 sq.ft. In the Soft Power District Phase III there is an approximate 229,206 sq.ft. (resulting in a required 1031 parking stalls with a proposed 1057 parking stalls. This requires 31 accessible stalls; 22 accessible stalls are provided.

The Soft Power Parking is identified on the attached plan as Phase III and IV in the Rushmore Crossing Parking Lot / Site Utility Plans. Utilities are linked between the proposed and future phases. As a result, the future phases have been included for information only.

Landscape Plantings

Landscape plantings have been submitted for review. As stated above the area is 633,214 sq.ft. equaling 633,214 landscape points - the building area and surround hardscape were not included in this submittal. 484,574 landscape points are included within this PCD boundary and 148,640 points will be taken from the Eglin St. ROW and monument sign plantings. There are approximately 267,700 points in the Eglin St. plantings and monument sign plantings. The following page is a breakdown of the landscape points.
