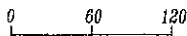


Plat of Lot 1 Revised and Lot 2 of Fort Hayes Subdivision

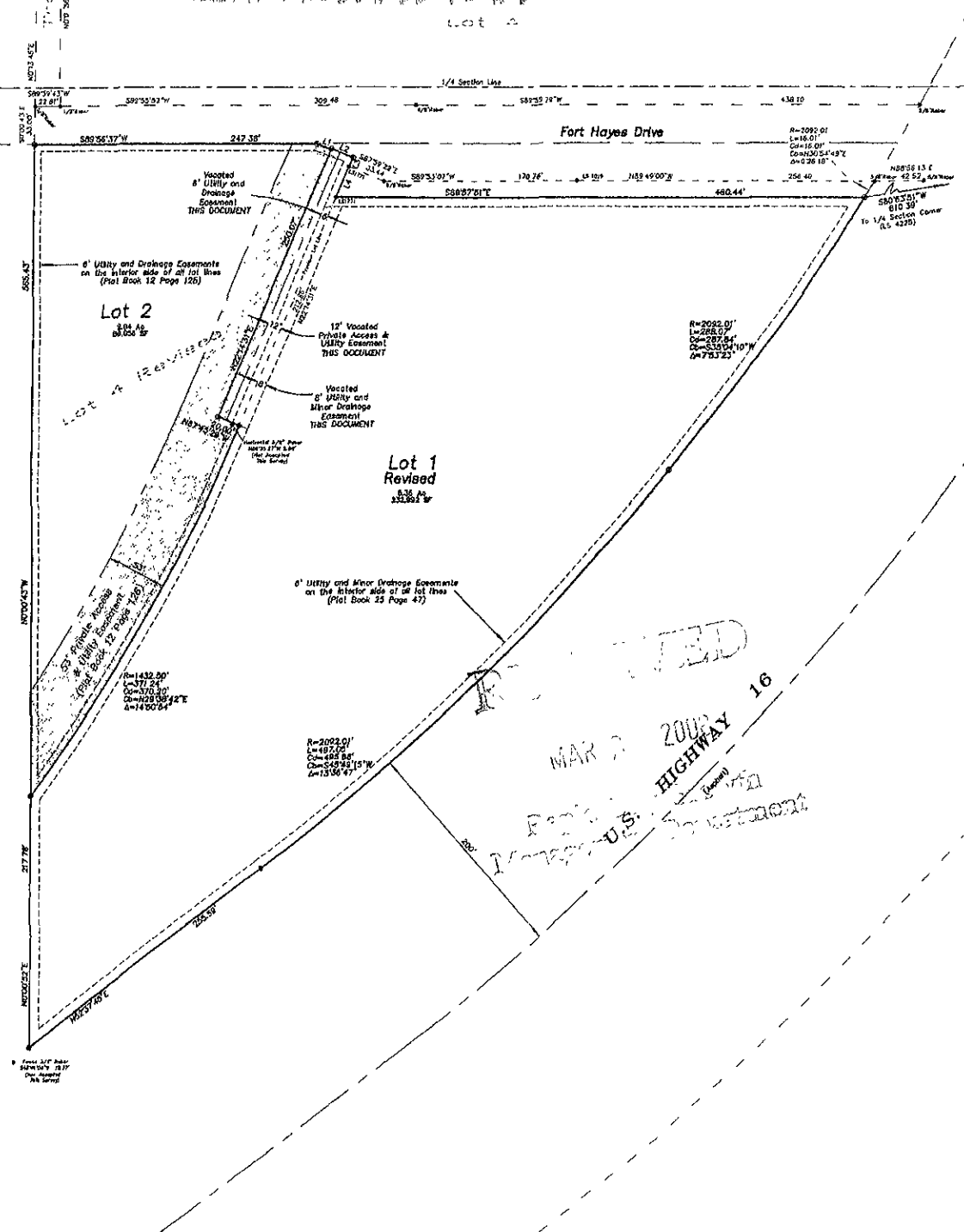
