# SUMMARY OF ADOPTION ACTION 

Amendment to the Comprehensive Plan

On April 21, 2008, the Rapid City Council approved an amendment to the Comprehensive Plan. The amendment will revise the Comprehensive Plan to change the land use designation from Low Density Residential District with a Planned Residential Development to Medium Density Residential District with a Planned Residential Development on a portion of Government Lot 4, Section 18, T2N, R8E, BHM, Rapid City, Pennington County, South Dakota, more fully described as follows: Commencing at the Section Corner common to Sections 13, 18, 19, and 24, and the point of beginning. Thence, first course: N00 ${ }^{\circ} 07^{\prime} 57^{\prime \prime} \mathrm{E}$, a distance of 607.71 feet, Thence, second course: S $89^{\circ} 45^{\prime} 23^{\prime \prime} \mathrm{E}$, a distance of 348.37 feet; Thence, third course: S45 ${ }^{\circ} 18^{\prime} 29^{\prime \prime}$ E, a distance of 148.27 feet; Thence, fourth course: S41 ${ }^{\circ} 57^{\prime} 10^{\prime \prime}$ E, a distance of 97.30 feet; Thence, fifth course: $560^{\circ} 00^{\prime} 17^{\prime \prime} E$, a distance of 82.33 feet; Thence, sixth
 distance of 89.82 feet; Thence, eighth course: N85 ${ }^{\circ} 07^{\prime} 42^{\prime \prime} E$, a distance of 72.62 feet; Thence, ninth course: N74²9'46"E, a distance of 101.06 feet; Thence, tenth course: N56 ${ }^{\circ} 32^{\prime} 29^{\prime \prime} \mathrm{E}$, a distance of 93.59 feet; Thence, eleventh course: S59 ${ }^{\circ} 22^{\prime} 45^{\prime \prime} \mathrm{E}$, a distance of 105.77 feet; Thence, twelfth course: S8945'23"E, a distance of 54.68 feet; Thence, thirteenth course: $\mathrm{SOO}^{\circ} 14^{\prime} 377^{\prime \prime} \mathrm{W}$, a distance of 117.37 feet; Thence, fourteenth course: S8945'23"E, a distance of 100.00 feet; Thence, fifteenth course: S00¹4'37"W, a distance of 40.61 feet; Thence, sixteenth course: S89037'07"E, a distance of 20.52 feet, to the northwesterly corner of Lot 1 of Mailloux Subdivision in Lot B in the SE $1 / 4$ of the SW $1 / 4$ of Section 18, T2N, R8E, BHM; Thence, seventeenth course: S00²3'45"W, along the westerly boundary of said Lot 1, a distance of 208.56 feet, to the southwesterly corner of said Lot 1 ; Thence, eighteenth course: $\mathrm{SOO}^{\circ} 23^{\prime} 45^{\prime \prime} \mathrm{W}$, a distance of 33.00 feet, to a point on the section line common to Sections 18, and 19; Thence, nineteenth course: N89 $35^{\prime} 54$ "W, along the section line common to Sections 18, and 19, a distance of 1290.05 feet, to the Section Corner common to Sections 13, 18, 19, and 24, and the point of beginning.
