Reallocation of Project Costs

Tax Increment District (TID) No. 42

Dear Committee Members:

In November 2007 the cost for Tax Increment District No. 42 were reallocated. The original allocation of cost was for both a Water Reservoir and Water Tower within the TID boundary. The November 2007 reallocation shifted the eligible cost to only a Water Reservoir and also identified project components in more detail. The November 2007 reallocation was based on a conceptual design for the Elk Vale Low Level Reservoir.

In August 2008 the Elk Vale Low Level Reservoir Project was bid and awarded. Therefore, the City of Rapid City Public Works Department requests the eligible costs for TID No. 42 be reallocated to more closely reflect the anticipated cost for each component of the project per the bid award. The reallocation requested is as shown on the attached spreadsheet in the Requested Allocation October 2008 column.

City staff members will be available at the next TIF Committee meeting to answer questions you may have concerning this request.
