**11-6-19 SDCL REVIEW
ENTRANCE SIGN
RAPID CITY REGIONAL AIRPORT**

DESCRIPTION OF REQUEST

The Rapid City Regional Airport requests approval from the Planning Commission in regards to the 11-6-19 SDCL review for the *ENTRANCE SIGN* project to be constructed at Rapid City Regional Airport at the intersection of Airport Road and Highway 44.

The original entrance sign at the Airport was removed during the reconstruction of Highway 44 in 2008. The Airport has been coordinating with the South Dakota Department of Transportation on a location for the replacement sign since the completion of the project earlier this year.

The sign will be approximately a 31'-10" long by 8'-5 5/8" high sign constructed of various materials including aluminum framing, stone base and a concrete pad and foundation. Sign is being designed by Berberich Design, Inc of Hill City, South Dakota.

Sign elevations and details along with a location map have been included for this 11-6-19 SDCL review.
