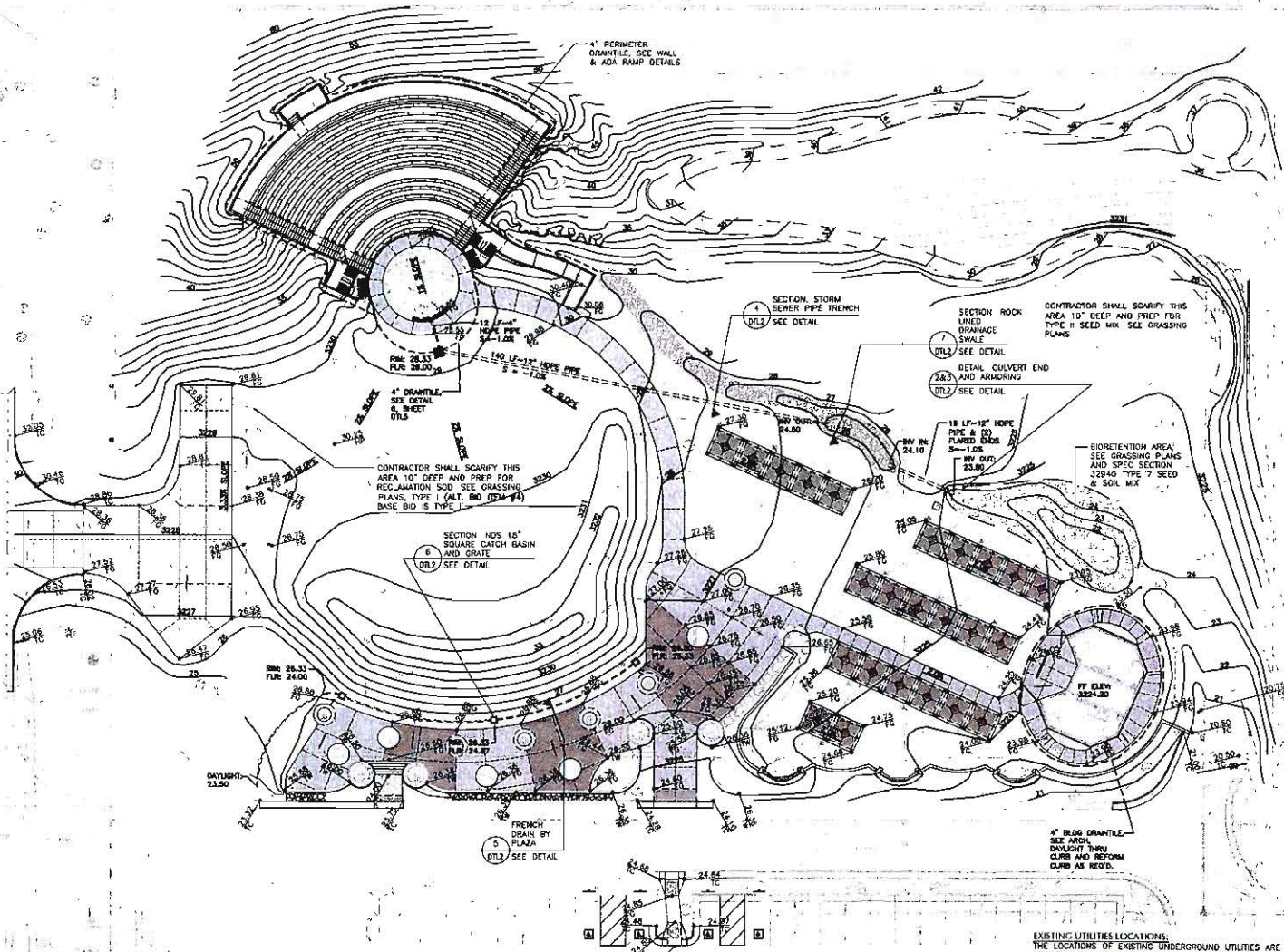

GRADING NOTES.

- BEFORE COMMENCING ANY CONSTRUCTION ACTIVITY, INSTALL A TEMPORARY ROCK CONSTRUCTION ENTRANCE AT EACH POINT WHERE VEHICLES EXIT THE CONSTRUCTION SITE. ROCK ENTRANCE SHALL CONSIST OF A 50 FOOT LONG 18 FOOT WIDE CURVED CONCRETE GRAVEL AGGREGATE MAT. LAY GEO-TEXTILE FABRIC BENEATH THE AGGREGATE. STRATEGICALLY PLACE CURBS TO PROTECT STOCKPILES. SHALL BE USED AS A BARRIER OF SEDIMENTATION RUNOFF. COORDINATE WITH LANDSCAPE ARCHITECT THE LOCATION OF THESE STOCKPILES.
- CONTRACTOR SHALL LIMIT THE CONSTRUCTION ACTIVITY TO THE AREAS DEFINED WITHIN THE GRADED AREAS AS SHOWN ON THE GRADING PLAN. CONTRACTOR SHALL USE DUSTING VEGETATED GRASSLANDS & NATIVE VEGETATION AS A BARRIER FOR SEDIMENTATION RUNOFF. COORDINATE WITH LANDSCAPE ARCHITECT THE LOCATION OF THESE AREAS.
