Re: Ugly Inc., Security Plan

To Whom It May Concern:

What follows is the security plan proposed by Ugly, Inc., with respect to its planned beer garden:

Ugly Inc. will hire five security officers from Ole Olson's Security to be on the premises from 3:00 p.m. to 3:00 a.m. These officers are licensed and bonded. Their job will be to ensure security of the area, that the beer garden is only open to individuals 21 and older, with all patrons being carded at either of the two entrances, both of which will be manned at all times during hours of operation.

There will be "coolers" on duty roaming the premises at all time, to diffuse any potential situations and to make sure the front gates are guarded at all times. Their job at the end of the night is to police for debris and empty bottles for the entire block upon which the beer garden is situated.

All beer served on the premises will be served in a red plastic cup to ensure it has been provided by Ugly Inc.

Ugly Inc. will begin operation with a four-foot high fence which completely encircles the beer garden, as approved by the police department, but Ugly Inc. is applying to the city council to be allowed to utilize a six-foot cattle guard fence.
