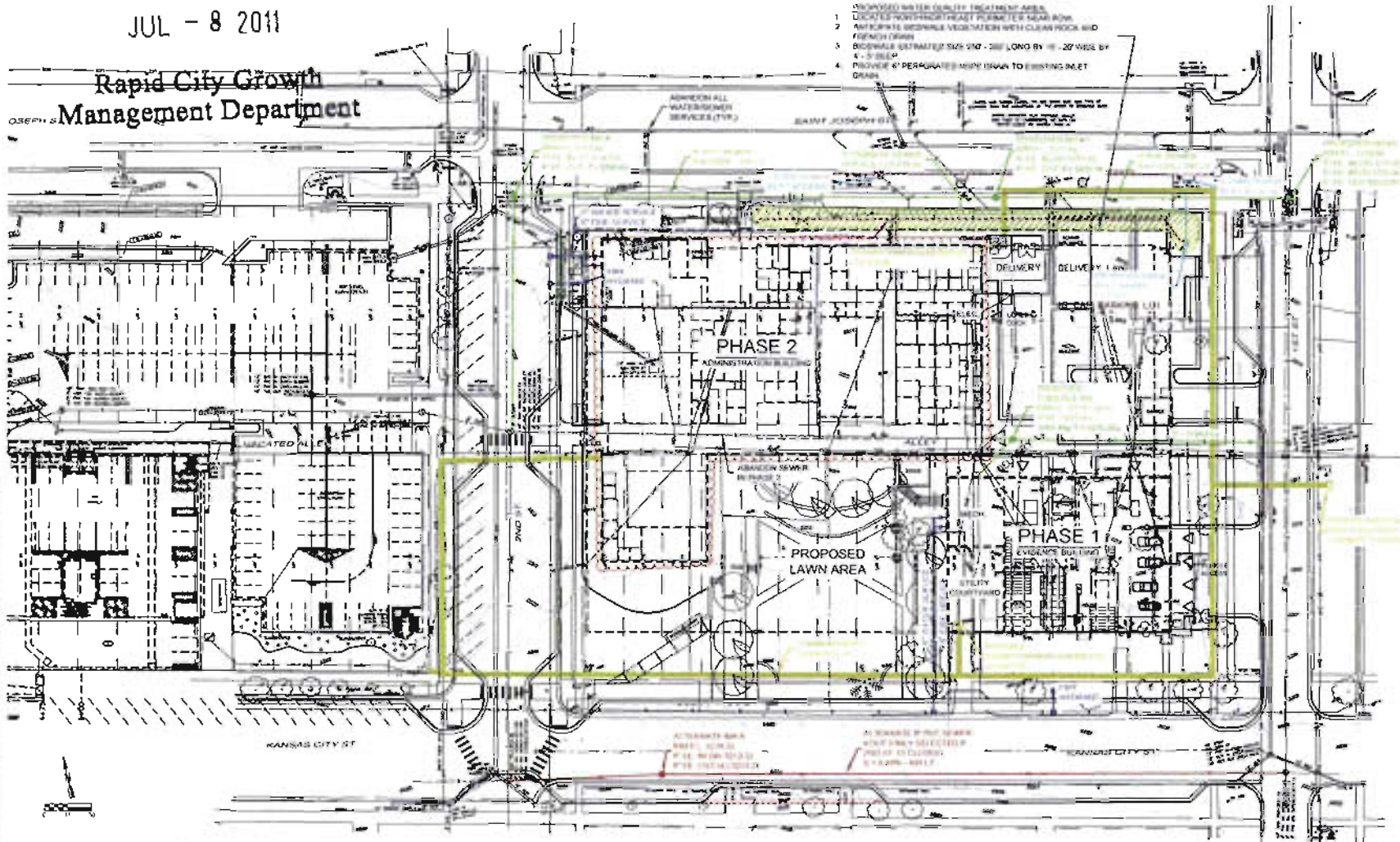


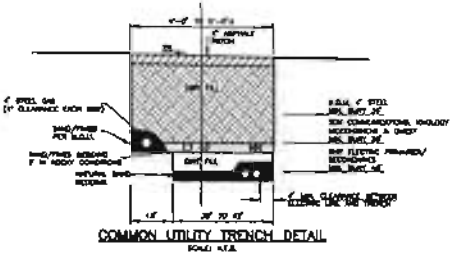

1. IMPROVED WATER QUALITY TREATMENT AREA
2. LOCATED WITHIN THE HEAT PLUMBER'S MAIN RUN
3. ANY EXISTING REMOVABLE VEGETATION WITH CLEAR ROCK AND FRENCH DRAIN
4. BIOWALLS ULTIMATELY SIZE 24" x 24" LONG BY 18" x 20" WIDE BY 4" x 5" DEEP
5. PROVIDE 4" PERFORATED MESH TISSUE TO EXISTING INLET DRAIN

1. REFER TO DIMENSIONS AND REMOVAL PLAN FOR SCOPE OF WORK
2. ASSUME ALL FACE FINISHES AND SLOPES WITHIN THE CURB & GUTTER OR BLOCK WALLS. EXPOSED DIMENSIONS IN REMOVAL STREET CROSSINGS/BIOWALLS REQUIRE PATCHING/REPLACEMENT

SPECIFICATIONS:

SPECIFICATIONS FOR ALL UTILITY, SITE, AND FINISHING WORK SHALL FOLLOW THE CURRENT CITY OF RAPID CITY STANDARD SPECIFICATIONS FOR PUBLIC WORK.

- UTILITY NOTES:**
1. ALL CITY UTILITY SERVICES MUST BE REMOVED AND ABANDONED PROPERLY BY THE CONTRACTOR. OTHER SERVICES MUST BE DISCONNECTED AT THE WATER MAIN WITH CLOSING OF CORPORATION STOP. SERVICE SERVICES MUST BE CAPPED ON THE BEARING WALLS APPROPRIATELY TO EACH PATCH PAVEMENT AT ALL LOCATIONS.
 2. PRIVATE UTILITIES SUCH AS: METRO GAS, BLACK HILLS POWER, MEDCO TECHNOLOGY, DIRECT AND RELATED SERVICES MUST BE PROPERLY DISCONNECTED FROM EXISTING STRUCTURES AND ABANDONED. PRIVATE SERVICES WILL REQUIRE NOTIFICATION IN ACCORDANCE WITH AFE PLANS.
 3. PROVIDE ALL FINISHING AND UTILITY RELOCATION REQUIRED BY CITY CROSSINGS AND CONCRETE FINISHING PROGRAM. REFER TO PROPOSED COMMON UTILITY TRENCH LOCATIONS AND PHYSICAL TRENCH DETAIL.
