WHEREAS, the proposed Amendment to the Comprehensive Plan would change the land use designation from Public to Residential for Block 76 of North Rapid Addition No. 2, located in Section 36, T2N, R7E, BHM, Rapid City, Pennington County, South Dakota, more generally described as being located 925 Dilger Avenue; and
