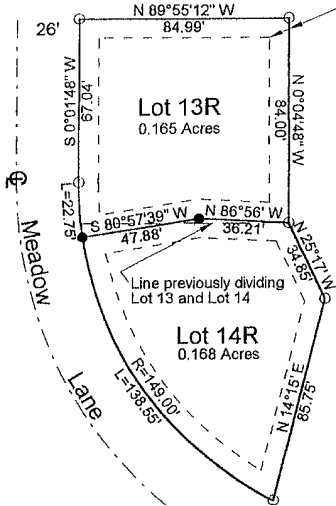


Plat of Lot 13R and 14R of Block 4 of Windmere Subdivision

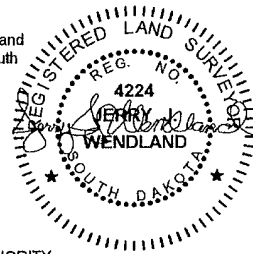
