SOUTH DAKOTA DEPARTMENT OF HIGHWAYS GUIDELINES FOR MAINTENANCE ON PRIMARY AND SECONDARY SYSTEM (Within Corporate Limits)

A. Towns Under 2500

- 1. Snow and Ice Removal
 - a. We do not remove snow and ice from driveways.
 - b. Normal plowing will be done through the towns. No hauling will be done except in severe snowfall conditions.
- 2. Surface Maintenance
 - a. Rural Section We maintain all the roadway surface. (Including Shoulders)
 - b. Curb and Gutter Section We maintain all the surface from back of curb to back of curb on all sections constructed with state funds. We do not maintain driveways but do have maintenance responsibility for the major intersections to the right-of-way limits. The state will clean the gutter if necessary for drainage.
- 3. Mowing and Right-of-Way Cleanup
 - a. Mowing behind curb on gutter sections will not be permitted, except in medians or outer separations.
 - b. Rural sections will be mowed to the right-of-way limits.
- 4. We do all the traffic control pavement marking (excluding marking for parking), signing, and other traffic control work in towns under 2500 in population.
- 5. Drop inlets will be cleaned once each year.

B. Towns Over 2500

- la. Surface maintenance limits are from back of curb to back of curb on curb and gutter sections.
- b. Surface maintenance limits for rural sections is the top width of the roadway or in undeveloped areas the full right-of-way width where a mutual agreement in writing between the city and the State Highway Department has been approved.

- 2. No mowing should be done in curb and gutter sections.
- 3. Mowing will be done for split medians, raised medians, and other areas when undesirable vegetation exists.
- 4. All maintenance of traffic control signs and painting of pavement markings shall be as follows:
