PR-A12 Fence Modifications: Change patio fence from galvanized to PVC bonded, install security fence around mechanical equipment, and omit fence around service area as identified in proposal request PR-A12. Add \$ 714.00

PR-A13 Omit Sidewalk & Entry Driveway: Omit the Waterloo Street sidewalk and south entry driveway as described in proposal request PR-A13. Deduct (\$ 5,015)

PR-A14 Repair Sewer Pipe: Remove asphalt pavement, excavate, repair sewer pipe, backfill, and replace asphalt pavement as described in proposal PR-A14. Add \$ 3,296.00

PR-A15 Repair Landscape Damage: Repair irrigation pipe & sprinklers and turf grass damaged from City utility repair work as described in proposal PR-A15. Add \$ 565.00

PR-A16 Extend Conduit for Sign: Extend electrical conduit to future sign location as described in proposal PR-A16. Add \$ 1,268.00

The original Contract Sum was	\$ 1,540,000.00
The net change by previously authorized Change Orders	\$ <u>14,151.00</u>
The Contract Sum prior to this Change Order was	\$ <u>1,554,151.00</u>
The Contract Sum will be increased by this Change Order in the amount of	\$ 828.00

The Contract Time will be increased by Four (4) days.
