We at Barker & Little, Inc are requesting the city take action to provide Rapid Ride bus services to the Signal Drive vicinity commonly known as Star Village. Additionally 76 residents of the area have signed a petition for bus service, a copy of same is enclosed.

Barker & Little, Inc is a property management company that owns and rents 202 apartments and mobile home units in Star Village. Recently, Barker & Little, Inc has contracted with the YMCA to provide Youth Outreach, a positive program for youth, to develop character and expose young people to programs at the library and Scouting. The program is open to all youth from our city-wide rental communities as well as youth from the surrounding neighborhood.


Our door to door survey conducted in December of this year resulted in responses that indicate the following:

- 1) An overwhelming request that bus service be made available to Star Village;
- 2) People need affordable public transportation to shopping, government agencies, medical services, and utilities.
- 3) A significant population surveyed does not drive for various reasons and need access to public transportation.
- 4) Children need transportation for the YMCA program as well as school and activities they attend.

We request that after you have reviewed this letter and petition signatures that you direct officials at Rapid Ride to consider a plan providing a bus route that would address the needs in this under-served community known as Star Village. Representatives of our company will be happy to meet with you or your designate to begin formation of a public transit solution for the area.

We appreciate the demands for services that your office must consider on a daily basis, but we believe this to be a matter of great public need. Thank you for your consideration of this matter. I look forward to visiting with you in the near future.
