Submitted herein is the Revised Assessment Roll for costs associated with the above referenced project.

Based upon the final Construction Change Order and the final Pay Request for this project, the total construction cost of the project was \$638,513.83. This cost includes two extra work quantities requested by the adjacent land developers. They will be billed separately. After deleting these costs, deleting oversized costs for water and sewer mains (to be paid by the Water Oversize and Sewer Oversize funds), and deleting the cost of the storm culvert (to be paid by the Drainage Basin Fees collected to date), the assessable construction costs are \$512,501.83.

I recommend that \$512,501.83 be accepted as the final construction costs of the project and that a total cost of \$644,576.27 be assessed to the parties involved. This final assessed cost includes \$66,577.50 engineering fees, \$5,570.26 interim construction finance fees, 5% construction engineering fees of \$29,234.48 and 5% Fiscal Agent fees of \$30,694.20. Total assessed amount to the various property owners listed is \$257,182.66. The remainder will be paid by the City.

Please see the attached, revised Final Assessment Roll that I have prepared. Note that there have been several subdivisions and subsequent changes of ownership within these subdivisions that have occurred in the interim. These changes, including the TID inclusion, have been accounted for in accordance with the Resolution of Necessity and as directed by the Public Works, Legal and Finance Committees and by the Council.
