The Additional Services included in this ADDENDUM will be completed for an amount not-to-exceed \$9,305.00.

The Additional Services included in this **ADDENDUM** will be performed in accordance with the Terms and Conditions of the Agreement for Professional Services dated June 7, 2004. The completion date for this contract will continue through completion and close-out of construction project.
