## MEMORANDUM OF UNDERSTANDING AND AGREEMEMT FOR SEWER SERVICE CONNECTION OF THE

BLESSED SACRAMENT CHURCH, RAPID CITY, SOUTH DAKOTA TO THE

RAPID CANYON SANITARY DISTRICT/CITY OF RAPID CITY SEWER MAIN

This Agreement executed this 2 day of \_\_\_\_\_\_\_, 2005, herein clarifies that the City of Rapid City accepts ownership and maintenance responsibilities of the sewer main from Manhole C8-1-2 up to and including Manhole C8-2-1. The Blessed Sacrament Church connection to said sewer main above the Rapid Canyon Sanitary District flow meter is hereby authorized in

accordance with the following conditions.

## SERVICE CHARGES

The Blessed Sacrament Church shall continue paying to the City, monthly sewer service charges based upon the volume of metered water entering the sewer and in accordance with the City Ordinance in effect at the time of billing reflecting any increase or decrease to the charge imposed by the City to be paid by a tenant or owner of a premises served by the wastewater collection and treatment system of the City.

The annual volume of Blessed Sacrament Church metered water, exclusive of irrigation metered water, shall be deducted from the annual Rapid Canyon meter totals prior to Rapid Canyon Sanitary District's annual billing by the City as stipulated in the April 18, 2005, Sewer Service Agreement Extension.
