In order to provide continuous sidewalks in the subdivision and at the request of the complainant, Engineering Services requests that the City Council order in sidewalks at these locations.

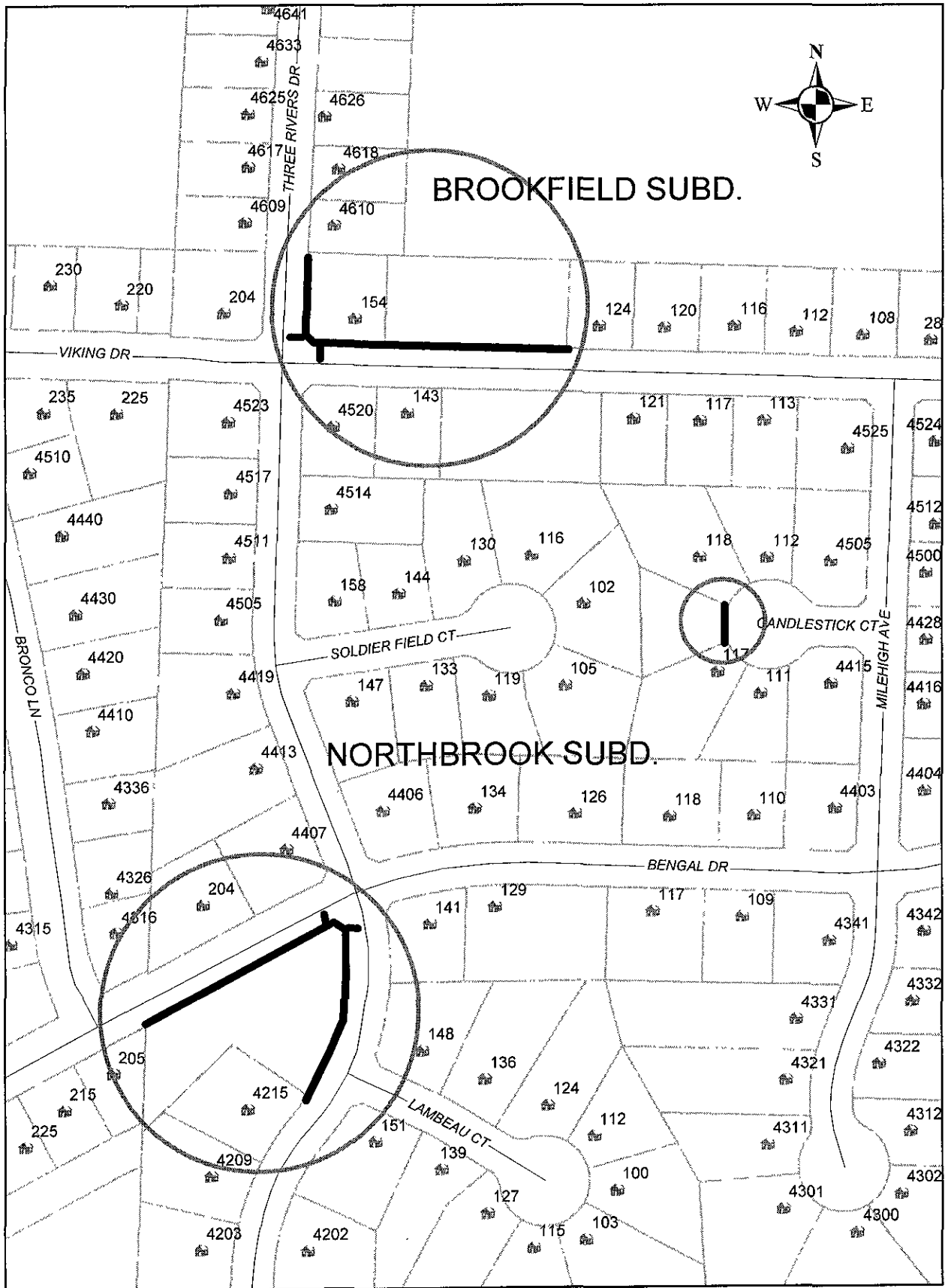
Please see the attached mapping. All of the drainage lots are owned by DTH, LLC, PO Box 330, Rapid City, South Dakota 57709.
