Background Information

Rapid City and Advanced Utility Systems Corporation (Advanced) entered into a Purchase License Agreement (the Agreement) on October 2, 2006. The Software License and Implementation Agreement and Section 5 of the Scope of Work provides that any changes to the project which impact project schedules, costs, resources and risk must go through a clearly defined Charge Order Process. Based on that provision, Advanced presents the following Change Order to Rapid City.

Change Details

Set up and Configuration of Current Rates

Based on the discussions between Advanced and the City of Rapid City, Rapid City noted that the water rates provided to Advanced for configuration into CIS Infinity were incorrect.

Upon review of the revised list of rates provided, Advanced must now:

- Re-configure the rates based on the new rate structures
- · Re-test revised rate configuration
- Re-establish rate mapping and upload to the Rapid City onsite system

Estimate of Hours / Costs

In order for Advanced to complete the necessary configuration, quality assurance and required testing for the provided rates, additional project hours are required, but not more than 70 hours charged at a rate of \$130.00 per hour. The City of Rapid City shall be billed based on the actual number of hours utilized. This change order shall not exceed \$9,100.
