Knollwood Drainage Outfall Elements 2 & 20 Project No. 50312-DR04-1390

This shall serve as Professional Services Agreement Amendment #1 to the referenced project. This amendment is for survey and 35% engineering design of Knollwood DBDP Elements 3 and 5. The study area begins about 300 feet downstream of Cambell Street and ends just east of the intersection of Spruce Street and East Denver Street where the storm sewers discharge into the open channel. The services include the full length of Element 5 as illustrated in the Knollwood Drainage Basin Design Plan.

Element 4 is noted in the DBDP as being adequate for flow conveyance. We have however included Element 4 for survey, analysis and preliminary design since it will be impacted by the Element 3 inlet and the Element 5 outlet.
