This declaration of the covenant and agreement ("Agreement") is entered into this It May of MAV, 2009, by and between Sandra Fredrickson, of 4555 Candlewodd Pl, Apt. 101/Rapid City, SD 57702 ("Landowner"), and the City of Rapid City ("City"), a South Dakota municipal corporation, 300 Sixth Street, Rapid City, South Dakota, 57701.

Landowner hereby acknowledges that she is the owner of record of the property in Rapid City, South Dakota which is legally described as:

Lot G of Tract C of South Part of Lot 7, Red Cliff Terrace Subdivision. located in the SW1/4NW1/4 of Section 9, T1N, R7E, BHM, Rapid City, Pennington County, South Dakota.

WHEREAS, Landowner has applied for a preliminary plat; and

WHEREAS, Landowner has granted a private water and sewer service line easement to Robert G. Devries and Jane Devries which will allow the Devries to access private water and sewer lines on the Landowner's property; and

WHEREAS, the City's Standard Specifications do not allow service lines to cross over another lot unless an Exception has been granted; and

WHEREAS, it is the parties' intention that an exception be granted to allow the non-conforming water and sewer service lines if the Landowner agrees to certain stipulations.

NOW THEREFORE, in consideration of the mutual covenants and conditions contained herein, it is agreed by the parties as follows:

1. Landowner hereby covenants and agrees to consent to an assessed project to install conforming water and sewer service lines in the future.

- 2. Landowner hereby covenants and agrees to defend, indemnify and hold the City harmless from all claims related to the non-standard service lines.
- 3. It is understood by Landowner that the City's primary consideration for the granting of the exception to the City's Standard Specifications on the above described property and granting preliminary plat approval is Landowner's covenant and promise to complete the Agreement conditions outlined in paragraphs 1 and 2 above.
- 4. The parties agree that the terms of this agreement shall be governed by the laws of the State of South Dakota. In the event of any conflict of laws, the law of the State of South Dakota shall be controlling without regard to the principles of conflict of laws. Any legal action arising out of or relating to this agreement shall be brought only in the Circuit Court for the State of South Dakota, Seventh Judicial Circuit located in Rapid City, Pennington County, South Dakota.
- 5. The City may undertake any legal or equitable action available to enforce the provisions of this agreement in addition to any remedy provided herein. In the event the City is required to undertake any action to enforce the terms of this agreement or its subdivision regulations in connection with this agreement, the undersigned, heirs, assigns, or successors in interest agree the City may recover from the owner of said property its reasonable expenses, including attorney's fees incurred with respect to such action.
- 6. All of the terms and conditions herein set forth shall extend to and be binding upon the heirs, assigns, or successors in interest of Landowner, and be considered as a covenant running with the above-described property. Furthermore, it is agreed that, in accepting title to the above-described property any grantee, heir, assign, or successor in interest to the undersigned expressly agrees to be bound by the terms of this Agreement recorded with the Pennington County Register of Deeds' Office pursuant to provisions of South Dakota statutes.
- 7. If any section(s), or provisions of this application is declared invalid for any reason whatsoever by any competent court, such invalidity shall not affect any other section(s) or provision of this application if they can be given effect without the invalid section(s) or provisions.

If the landowner is a corporatio	n, it has the power to	enter into this	agreement and its
officers signing for it have full	power and authority t	o do so.
