RECOMMENDATION:

Staff recommends that the Vacation of a Sanitary Sewer Easement be approved with the following stipulation:

1. Prior to Public Works Committee approval, the proposed Water and Sewer Easement shall be recorded at the Register of Deed's Office and a copy of the recorded document shall be submitted to the Growth Management Department.

GENERAL COMMENTS: The applicant has submitted a request to vacate an existing 20 foot Sanitary Sewer Easement located on Lot 2, NWE Subdivision. In addition, the applicant has submitted documentation identifying an alternate location for 30 foot Utility Easement on the property, as well as an associated Vacation of Right-of-Way application (#09VR009) vacating a portion of Dean Lane and an SDCL 11-6-19 Review application to allow construction of a street in public right-of-way and to extend public utilities on public property.

No. 09VE018 - Vacation of Sanitary Sewer Easement

ITEM

The property was originally platted in 1998. The existing 20 foot Sanitary Sewer Easement was dedicated on the plat in anticipation of future development of the property. The applicant is proposing to relocate the easement to accommodate the proposed site development. The property is owned by the State of South Dakota and is the future site of the South Dakota Game, Fish and Parks Outdoor Campus West.

The property is located west of Sturgis Road, south of Knutson Lane and north of Dean Lane. The property is zoned Public District and currently void of any structural development.

<u>STAFF REVIEW</u>: Staff has reviewed the Vacation of a Sanitary Sewer Easement request and has noted the following considerations:

<u>Utility Easement</u>: As noted above, the applicant has submitted documentation proposing to dedicate an alternate 30 foot Utility Easement to accommodate the utilities for the proposed Outdoor Campus. City staff has reviewed and approved the proposed location of the alternate Water and Sewer Easement. Prior to Public Works Committee approval, the proposed 30 foot Water and Sewer Easement must be recorded at the Register of Deed's Office and a copy of the recorded document must be submitted to the Growth Management Department.

Staff has received comments back from all of the impacted utility companies and they have indicated that the proposed sanitary sewer easement vacation has no impact on their existing utility operations.

Staff recommends that the Vacation of the Sanitary Sewer Easement request be approved with the above referenced stipulations.
