FOR AND IN CONSIDERATION of the sum of One Dollar (\$1.00), and other good and valuable consideration, the receipt and sufficiency of which is hereby acknowledged, the CITY OF RAPID CITY, a South Dakota municipality, 300 Sixth Street, Rapid City, South Dakota, 57701, Grantor, hereby grants to RAPID CITY AREA SCHOOL DISTRICT NO. 51-4, of 300 Sixth Street, Rapid City, South Dakota, 57701, the Grantee, a permanent utility easement in, on, over, under, and across the following described real property:

A strip of land twenty feet (20') in width, in, on, over and across Tract Nineteen (19) of Rapid City Greenway Tract located in the East Half (E½) of Section Thirty-five (35) and in the West Half (W½) of Section Thirty-six (36), all in Township Two North (T2N), Range Seven East (R7E) of the Black Hills Meridian, Pennington County, South Dakota, as shown on Exhibit "A", attached hereto and incorporated herein by reference.

Such easement shall include the right to enter upon the easement property to construct, install, operate, inspect, and maintain a water main, together with all related appurtenant facilities upon said property. The City shall perform all work in a workmanlike manner and shall leave the property in as good condition as existed prior to entry thereon.

The area which is the subject of this easement shall be kept free of all obstacles, including fences, shrubs, walls, or other items which obstruct the visibility or usefulness of the easement.

This easement shall include the right to enter upon the above described real property and otherwise to do those things reasonably necessary to effectuate its purpose.

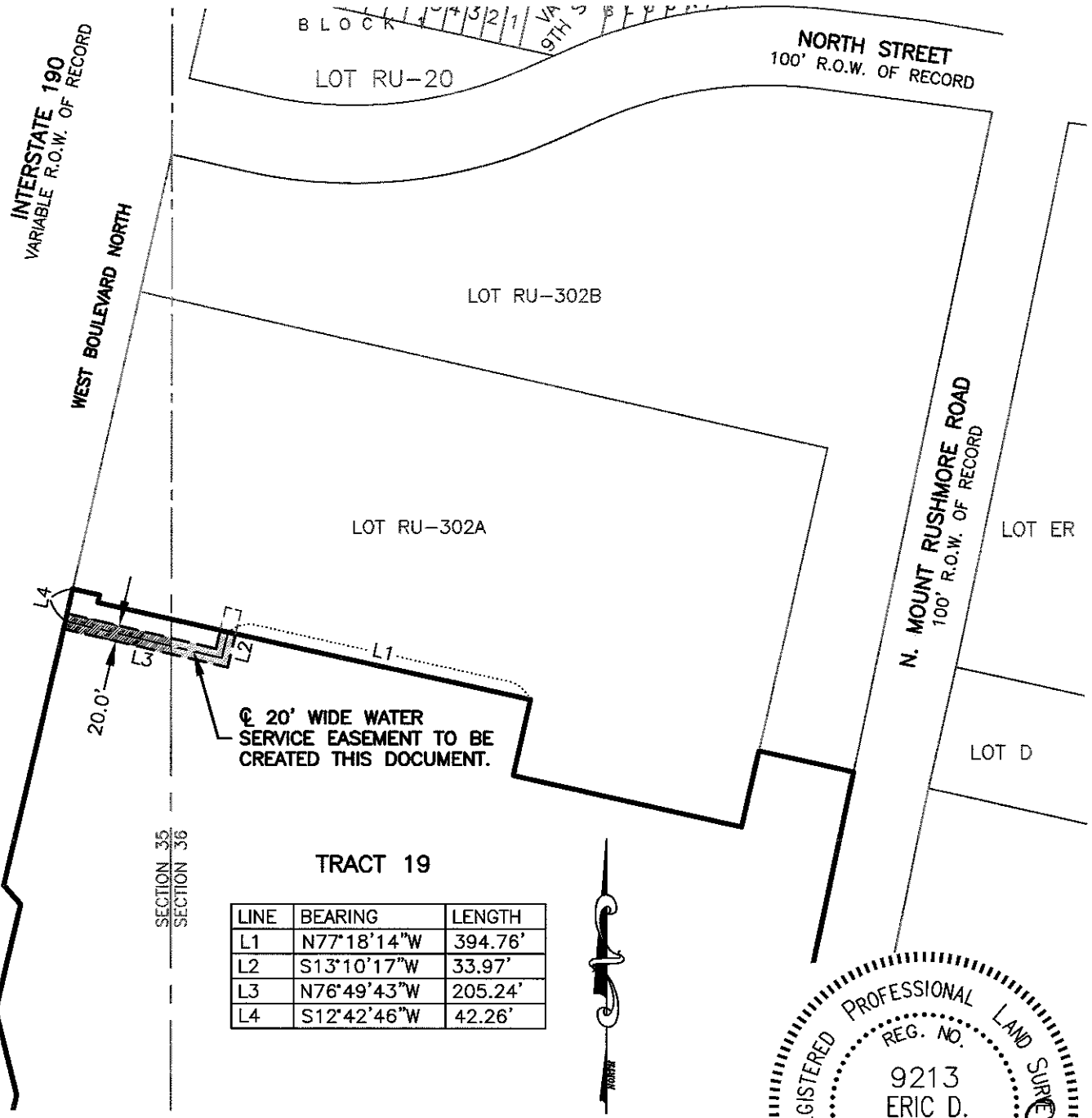

20' WIDE WATER MAIN EASEMENT, TRACT 19 OF THE RAPID CITY GREENWAY TRACT

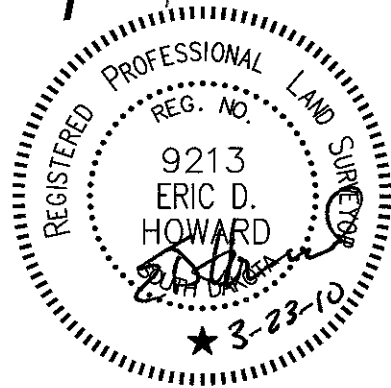
LOCATED IN THE E1/2 OF SECTION 35 AND IN THE W1/2 OF SECTION 36

RAPID CITY, PENNINGTON COUNTY, SOUTH DAKOTA



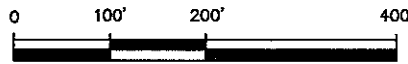
