 III. Project/Item(s) Description: Construction of sanitary sewer main in the Heights Drive area.
*\$330,000.00 will be transferred from the 835 utilities/facilities fund into the 834 sanitary sewer fund for this project. On 12/6/2010, Resolution #1210-168 was approved by City Council. This resolution provides a cap of \$7,500 to the amount that property owners not currently connected to the City's sanitary sewer system must pay to connect to the City's system. The non-conforming portion is for the property located at 4901 Heights Drive. This portion of the project will eliminate a non-conforming sanitary sewer service. The City will pay 50% of the non-conforming portion of the project per ordinance 13.06.020.
