This Amendment modifies terms and conditions of "Professional Services Agreement between the City of Rapid City and CETEC Engineering Services, Inc. for Construction Phase Services for Saint Andrew Street Reconstruction Phase 2 — Lincoln Ave. to Elm Ave. Project No. ST10-1803 / CIP #50714" dated May 4, 2010. The terms and conditions of the referenced agreement shall remain unchanged unless specifically modified by this Amendment No. 1.

CHANGES TO AGREEMENT:

Background

Construction contract required the Contractor to have all surfacing work completed by August 6, 2010 with remaining restoration work to be complete by September 10, 2010. Contractor completed surfacing and associated work September 17, 2010 with final punch list items completed October 15th. Contractor was charged 31 days of liquidated damages. 5 additional contract days were negotiated for additional work completed outside of the scope of the original contract. Final liquidated damages are 26 days at \$650/day for a total of \$16,900.00.

Agreement for Engineering Services estimated 5 hrs/day for construction observation on the project from August 6, 2010 to September 10, 2010.

Request

Request to amend compensation for Task 5.5 based on actual hours worked on construction observation between August 6th and October 15th 2010.

The Contractor worked multiple weekends throughout the duration of the project to keep the project on schedule and site inspection was required. Weekend work was not anticipated or included in the original estimate.

It was anticipated that only part time construction observation would be necessary between August 6th and September 10th as all of the underground utility installation and surfacing work was to be complete August 6th. Utility and surfacing work continued up to September 13th.
