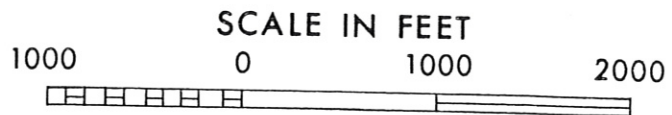




MATCH LINE PLATE 18

HIGH WATER MARK DESCRIPTIONS (Continued)

<u>Number</u>	<u>Description</u>
RC-8	Sec 8, T1N, R8E. Metal tag with red flagging on power pole on Valley Drive. The pole is west of Valley Drive, north of the bridge.
RC-9	Sec 5, T1N, R8E. Metal tag with red flagging on power pole on Creek Drive. The pole is east of Creek Drive at the north edge of the bridge.
RC-10	Sec 8, T1N, R8E. Metal tag with red flagging on power pole on east St. Patrick. The pole is located directly south of the abandoned sewage treatment plant. The pole is south of East St. Patrick Street about 50 feet to 75 feet.
RC-11	Sec 6, T1N, R8E. Metal tag with red flagging on the power pole. The pole is across the street from the Gillette Dairy to the east. The pole is on the east side of Cherry Avenue.
RC-11a	Sec 6, T1N, R8E. Metal tag with red flagging on tree, south of South Dakota Highway 79. The tree is north the fence around the stadium. (South Dakota School of Mines).
RC-12	Sec 6, T1N, R8E. Metal tag with red flagging on the pole supporting the billboard sign. The sign is north-west of the bridge at Cambell Street and west of Cambell Street.
RC-13	Sec 6, T1N, R8E. Metal tag with red flagging on the power pole. The pole is located downstream from the San Francisco Street bridge on the left bank.
RC-13a	Sec 6, T1N, R8E. Metal tag with red flagging on the power pole. Intersection of East Main south and Elm Avenue. The pole is on the southwest corner of East Main south and Elm Avenue.
RC-14	Sec 6, T1N, R8E. Metal tag with red flagging on the power pole. The residence in Photo is 208 North Maple Avenue. The pole is east of North Maple Avenue and south of the bridge.
RC-14a	Sec 1, T1N, R7E. Metal tag with red flagging on the power pole. The intersection of Main Street and East Boulevard is the location. The pole is on the southwest corner of the intersection near Bowman Tire Service.
