Dear Property Owner:

The City of Rapid City has in the past mowed the right-of-way areas adjacent to private property as situations allowed. The City will no longer be maintaining any right-of-way areas. The adjoining right-of-way areas are the responsibility of property owners, and need to be maintained according to Municipal Codes pertaining to the mowing of grass and weeds.

The City is making a pre-emptive effort to inform property owners of their responsibilities before the growing season. Grass and weeds on private property are required to be mowed, to under 8" inches, to comply with City regulations. The Maintenance of adjacent right-of-ways is also the responsibility of the adjoining property owner.

## **8.28.020** Prohibited conditions.

All grass and weeds having reached a height of 8 inches, and other noxious matter are declared a nuisance and no owner of any lot, place or area within the city, or the agent of the owner or the occupant of the lot, place or area, shall permit on the lot, place or area, or upon any sidewalk abutting the same, any grass and weeds having reached a height of 8 inches, or other noxious matter to grow, lie or be located thereon.
