Appointments to the Code Enforcement Board of Appeals (CEBA)

#### **ORDINANCE No. 5827:**

The Code Enforcement Board of Appeals shall consist of 5 members and 2 alternates appointed by the mayor and confirmed by the common council. Initially, three members shall be appointed for terms of 1 year, two members for terms of 2 years, and two members for terms of 3 years; thereafter, all terms shall be for 3 years and vacancies shall be filled for the unexpired term only. No CEBA member may serve on the board for more than 2 consecutive terms. Each member shall be a citizen of Rapid City. No current city employee, elected city official or paid city consultant shall be allowed to serve as a voting member of the CEBA.
