 II. PROJECT NAME: Homestead – Meadow Ridge Drive Water Transmission Main Extension – Project One
 III. Project/Item(s) Description: The Project is based on the July 2009 report titled, "Final Water Supply Study Rapid City Regional Airport, Rapid City, South Dakota", by KLJ and AE2S. A 16" PVC water transmission main is proposed to be extended from an existing 16" main on Homestead to the airport. The water transmission main will be bid under four separate projects. This project consists of approximately 1,700 feet of 16 inch water main and associated appurtenances. This project is located in future Homestead Street and existing Meadow Ridge Drive. The improvements when constructed will provide 3,000 gpm for fire flow and allow an additional 500 gpm to be made available for growth/economic development in and around the airport. The project will also provide redundancy by looping the distribution system.

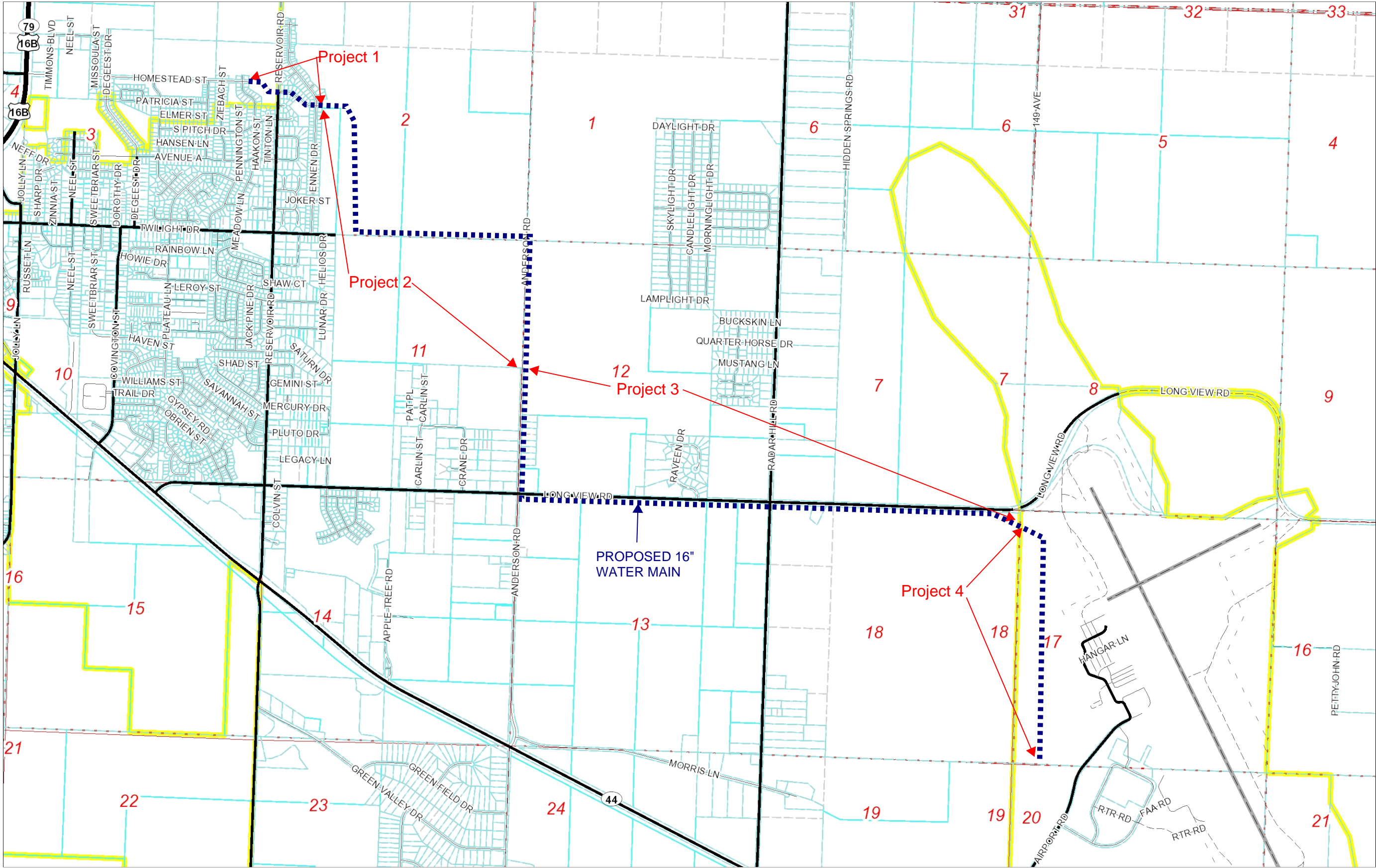
