Dear Mrs. Finck:

The request for an exception to allow an alley as the primary access point for the proposed townhouse lots has been denied. The proposed alley, as submitted, has 18' of pavement within 20' of right-of-way, without curb, gutter, sidewalk, or protected ADA compliant pedestrian corridor, presents several issues for use as primary access to the proposed properties. As mentioned in your Letter of Intent, the main reason for proposing the alley as primary access is that the front yard grade prevented ADA accessibility from the front. For this reason it is important to provide ADA accessibility within the alley in order to reach the rear of the homes from adjacent streets. In addition the lack of curb and gutter presents drainage issues with regional drainage flowing across the proposed alley right-of-way and onto private properties. Adding curb and gutter also provides vertical separation between vehicles and pedestrians and facilitates maintenance of the proposed public roadway.

The denial of this exception request may be appealed to the City Council by requesting it be placed on the next Public Works Committee agenda. The City Council has final approval of exception requests. In order to appeal the denial the applicant shall file a written request of appeal to the Public Works Director within 10 working days of the denial. Please contact the Public Works Engineering Department if you desire to appeal.
