Recommendation:

The above listed properties were officially de-annexed from Rapid City on November 7, 2014. The official date of de-annexation occurred after the finalization of the Stormwater Drainage Utility special assessments. Once Pennington County has applied the special assessments, adjustments can only be made through the abatement process. The properties will not be within Rapid City limits during assessment year 2015, and therefore are not applicable to ordinance 5965 which established the Stormwater Drainage Utility fee.




