### PURPOSE:

Per section 2.60.020 of the Rapid City Municipal Code members of the City Planning Commission shall consist of nine voting and two alternate positions. Eight members shall be residents of the City with one member representing the 3-mile jurisdiction of the City.

Ordinance No. 6031, a companion ordinance, clarifies that the Planning Commission will serve as the Board of Adjustments, also commonly referred to as the Zoning Board.
