- ALTERNATE #1: Provide granite planter curbs in lieu of the Base Bid precast planter curbs.
ALTERNATE #2: Add metal planter rails to Right-of-Way planter.
ALTERNATE #3: Provide granite lawn steps in lieu of the Base Bid cast-in-place concrete steps.
ALTERNATE #4: Add awnings to garage façade.
ALTERNATE #5: In lieu of excavating individual foundations and utility trenches, contractor shall mass excavate the site (as defined by the Public Right-of-Way lines and the 15' easement at the Sears building) to a depth of 4' below proposed grade. Contractor shall build up to proposed subgrade from this level with clean engineered fill.
ALTERNATE #6: Provide 6" caliper trees in lieu of Base Bid 4" caliper trees.
ALTERNATE #7: Provide precast slab pavers in lieu of Base Bid colored concrete.
ALTERNATE #8: Provide pedestrian clay brick paver sidewalks at Main Street, Sixth Street, and along Sears Building in lieu of Base Bid concrete sidewalks
ALTERNATE #9: Provide vehicular clay brick pavers at the alley in lieu of Base Bid vehicular concrete.
