Sam Kooiker having received a majority of all votes cast for the office of Mayor for a term of two years, is hereby declared to be duly elected to the office of Mayor of the City of Rapid City for the term as hereinabove set forth, and is entitled to qualify for and hold said office as provided by law; and

2. Charity Doyle, having received a majority of all votes cast for the office of Alderman for the First Ward, for a term of two years, is hereby declared to be duly elected to the office of Alderman of the City of Rapid City for the First Ward and for the term as hereinabove set forth, and is entitled to qualify for and hold said office as provided by law.

3. Ritchie Nordstrom, having been unopposed as candidate for the office of Alderman for the Second Ward, for a term of two years, is hereby declared to be duly elected to the office of Alderman of the City of Rapid City for the Second Ward, and for the term as hereinabove set forth, and is entitled to qualify for and hold said office as provided by law.

4. Jerome Wright, having been unopposed as candidate for the office of Alderman for the Third Ward, for a term of two years, is hereby declared to be duly elected to the office of Alderman of the City of Rapid City for the Third Ward, and for the term as hereinabove set forth, and is entitled to qualify for and hold said office as provided by law.

5. John B. Roberts, having received a majority of all votes cast for the office of Alderman for the Fourth Ward, for a term of two years, is hereby declared to be duly elected to the office of Alderman of the City of Rapid City for the Fourth Ward and for the term as hereinabove set forth, and is entitled to qualify for and hold said office as provided by law.

6. Bradley H. Estes, having received a majority of all votes cast for the office of Alderman for the Fifth Ward, for a term of two years, is hereby declared to be duly elected to the office of Alderman of the City of Rapid City for the Fifth Ward and for the term as hereinabove set forth, and is entitled to qualify for and hold said office as provided by law.

BE IT FURTHER RESOLVED that this resolution is found and determined to be necessary for the immediate preservation of the public peace, health, and safety, and for the support of the municipal government and its existing public institutions, wherefore an emergency exists and this resolution shall take effect immediately upon its passage and publication according to law.
