

**RESOLUTION NO. 2015-064 CANVASSING VOTE FOR THE  
MUNICIPAL SECONDARY ELECTION HELD JUNE 23, 2015**

WHEREAS there was held in the City of Rapid City, South Dakota, on Tuesday, the 2nd day of June, 2015, the Annual Election of the City of Rapid City, South Dakota, for the purpose of electing a Mayor and five Alderpersons of said City; and

WHEREAS at said election no candidate for Ward Three Alderman received a majority of the votes cast for that office; and

WHEREAS a secondary election was called for the purpose of electing an Alderman for the Third Ward between the two candidates receiving the highest number of votes cast for those respective offices in the Annual Municipal Election; and

WHEREAS there was held in the City of Rapid City, South Dakota, on Tuesday, the 23rd day of June, 2015, a Secondary Municipal Election for the purpose of electing an Alderman from the Third Ward of said City; and

WHEREAS at said election the total number of votes cast for the office of Alderman were as follows:

Wright having received a majority of all votes cast for the office of Alderman for the Third Ward, for a term of two years, is hereby declared to be duly elected to the office of Alderman of the City of Rapid City for the Third Ward and for the term as hereinabove set forth, and is entitled to qualify for and hold said office as provided by law.

BE IT FURTHER RESOLVED that this resolution is found and determined to be necessary for the immediate preservation of the public peace, health, and safety, and for the support of the municipal government and its existing public institutions, wherefor an emergency exists and this resolution shall take effect immediately upon its passage and publication according to law.
